Entries can be sent at any time. However, entries from members of the Pembroke Welsh Corgi Club of the Garden State with Pembroke Welsh Corgis have preference until March 3, 2017.

Entries from non-members with Pembroke Welsh Corgis who have not previously been in a PWCCGS Herding Instinct Test have preference until March 10, 2017.

After that date all entries will be accepted, by postmarked date, for all Pembrokes and other herding breeds.

All entries close on March 24, 2017.

Dogs must be at least 6 months old.

For the Herding Instinct Test, dogs need have NO training on stock. Any dog endangering stock by biting or excessive chasing will be excused.

Any dog showing aggression toward people in or out of the ring will be asked to leave the grounds.

All dogs must have proof of current rabies vaccination available for inspection if requested.

Bitches in heat may take part in the test, but must wait until all other dogs have participated.

Dogs must be on leash at all times except while competing. For their safety, children must be under supervision at all times, and not allowed to run around the farm or climb on fences or equipment. Unruly children will be asked to leave the grounds.

You will be assigned a fifteen-minute time period. Please check your confirmation and be on time. We strongly suggest you plan to arrive at least ½ before your scheduled time, to allow for absences and dogs who do not use the entire 15 minutes they are allotted.

## **GENERAL INFORMATION:**

**ENTRIES/RELEASE**-You must use the entry form provided at the end of this document. **The release must be signed** by all adults (and for minors) who will be in attendance. Additional forms will be available at the test.

**CONFIRMATION OF ENTRY** will be sent after entries close with your dog's scheduled time. **Checks are not cashed until after the test.**

**DRESS** - This is a working farm. Please dress appropriately - long pants, old shoes. Be aware we will be working rain or shine, so bring your rain gear.

**IMPORTANT** - **Keep all dogs at least 50 feet away from arena on a leash or in a crate. Pick up after your dogs and do not litter.**

**SPECIAL REQUIREMENTS** - Please bring chairs, water for your dog, bug spray, and any other special items you or your dog may require. There will be no food available at the farm. There is a restaurant a short distance from the farm.

**DIRECTIONS:** NJ Turnpike South to Exit #7/BORDENTOWN/TRENTON US-206 South. Go 8.3 miles south of the Red Lion Circle (i.e., the intersection of Rt 206 and Rt 70).

Turn right toward Medford onto Stokes Rd (also called Rt 541).

House is third on left. Brown house with a brown fence that goes right up to the road.
