The parties below enter into this Contract on the above date for the adoption of the aforementioned Pembroke Welsh Corgi. The adopting party/parties understand that non-compliance with the terms for this agreement or falsification of this agreement gives the PWCCGS the right to reclaim this Corgi without refund of the adoption fee. The adopting party/parties further agree to the following terms:

1. To return the Corgi to PWCCGS Rescue if unable to keep the dog at anytime within the dog's life.
2. The Corgi will NEVER be given to another party, animal shelter, pound, humane society or research program.
3. The Corgi will be a house pet and treated with affection.
4. The Corgi will never be allowed outside without being on a leash attached to an appropriate collar and will never be allowed to "run loose".
5. The Corgi will be fed a high quality diet and receive regular veterinary care.
6. To notify PWCCGS Rescue and provide a new address and phone number if the adopting party/parties move.
7. To allow representatives of PWCCGS Rescue to periodically check on the Corgi in person and by phone.
8. To pay a \$_____ adoption donation upon receipt of the Corgi.
9. To be responsible for any and all legal fees incurred if a violation of this contract results in a legal suit.
10. The adoption donation is refundable during the first month of ownership upon return of the Corgi.

The undersigned adopter has been advised of the previous terms and agrees to accept all responsibility for adoption and agrees to all conditions of this contract.

RELEASE OF LIABILITY AND INDEMNIFICATION

I/WE PROMISE AND AGREE TO BE SOLELY RESPONSIBLE FOR THIS ANIMAL AND TO INDEMNIFY AND HOLD HARMLESS THE PEMBROKE WELSH CORGI CLUB OF THE GARDEN STATE, INC. (PWCCGS), PWCCGS RESCUE VOLUNTEERS, PWCCGS MEMBERS FROM ANY AND ALL CLAIMS OF LIABILITY FOR THE CONDUCT OF THIS CORGI ON OR AFTER THE DATE OF THIS ADOPTION. I/WE ALSO AGREE THAT IF I/WE KNOWINGLY BREAK ANY OF THE ABOVE AGREEMENTS IN THIS CONTRACT, THAT I/WE ARE LIABLE TO BE SUED FOR BREACH OF CONTRACT BECAUSE THIS IS A LEGAL DOCUMENT, TO BE UPHELD IN A COURT OF LAW.

THE UNDERSIGNED FURTHER AGREE(S) AND INTEND(S) THAT THIS RELEASE OF LIABILITY AND INDEMNIFICATION SHALL APPLY TO ALL KNOW, UNKNOWN AND UNANTICIPATED DAMAGES RESULTING FROM MY/OUR ADOPTION, OWNERSHIP OR CONTROL OF THIS ANIMAL. THIS IS A BINDING CONTRACT, ENFORCEABLE BY CIVIL LAW.
